- 3. The cost of tender paper should be submitted, without which the quotation will be liable to be rejected.
- 4. Quotation will be received by AAO (Tech), NRRI only or courier or speed/registered post. Quotations will not be received after last date and scheduled time. NRRI will not be held responsible for postal/courier delay.
- 5. The bid will be opened at 3.00 P.M. on 05.02.2020 at ICAR-NRRI, Cuttack-753006 in presence of the tenderers who may wish to be present.
