Online bids are hereby invited on behalf of the Director, NRRI, Cuttack-6 for specialized work FOR **"Renovation for TWO Unit Rainout Shelter" NRRI, CUTTACK-6.** The terms and conditions of the specialized works are detailed in the tender document. Please submit your offer if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached Annexures. Please submit your financial bid online and all other documents need to be submitted both online and in hardcopy format Director, NRRI, Cuttack before tender closing date.

- 1) The earnest money deposit (EMD) of Rs. 15,000/- (Rupees Fifteen Thousand only) must be deposited in the form of demand draft in favour of Director, NRRI, Cuttack-6 payable at S.B.I. Nayabazar Branch, (Code 2094). The particulars of the earnest money deposited must also be super-scribed on the top of the envelope by indicating the draft number and date, failing which the tenders will not be opened. The tenders will not be considered if earnest money is not deposited with the tenders. The EMD shall be refunded to unsuccessful firm without paying any interest by the NRRI. A bidder accepting the request and granting extension shall not be permitted to modify his bid.
- 2) The firm, after submitting tender, will not be permitted to withdraw their offer or modify the terms and conditions thereof. If the firm fails to observe and comply with the foregoing stipulation, EMD will be forfeited. In the event of the offer made by the firm not being accepted, the amount of EMD will be refunded, in the manner prescribed by the NRRI.

(B) Operative terms and conditions (For locations at Annexure- II)

Terms and conditions:-

1. The two separate bids shall contain information as under:-
  - a) Technical Bid: This shall contain the entire tender document, except Annexure-VI, which relates to the Financial Bid, with each page signed with the Rubber Stamp of the Bidder. This will also enclose the scanned copy of Earnest Money Deposit (EMD) amounting to Rs. 15,000/- (Rupees Fifteen thousand only) must be deposited in the form of demand draft in favour of Director, NRRI, Cuttack-6 payable at S.B.I. Nayabazar Branch, (Code 2094).. All other required supportive documents towards eligibility and experience criteria as mentioned in Annexure IV shall be submitted online. No price shall be mentioned in this document anywhere. If price is mentioned in the technical bid, the offer is liable to be rejected.
  - b) Financial Bid: This shall contain the schedule of rates duly filled and signed in the prescribed formats i.e. Annexure VI.
2. The tender must be in the prescribed formats only and shall be accompanied with all other necessary documents. The consolidated monthly amount to be charged has to be indicated in Indian Rupees both in words and figures (in the prescribed proforma of Financial Bid) and there shall be no correction or overtyping etc. The offers with any corrections/deviation in prices wither in words/figures shall be summarily ignored. The conditional offer (s) shall, in no case, be accepted.
3. The work shall be awarded to a single firm whose consolidated bid value is lowest meeting all scopes of work and fulfilling all the terms and conditions of the tender, with specific reference to the essential condition relating to the availability of requisites infrastructure/facilities and experience of similar nature.
4. The financial bid will be opened only for those bidders who will be technically qualified in the technical bid. The past performance of the bidders with user Departments will be important criterion in evaluating the technical bid. The Director, NRRI reserves the right to reject all or any of the quotations, and decision of the Director, NRRI in the matter shall be final and binding.
5. The tendering firm has to carefully assess the scope of work with specific reference to the inside and outside premises of the building and understand the details of the infrastructure/facilities requisitioned. The tenderer may, in their own interest, inspect the site i.e. inside of NRRI Campus at NRRI, Cuttack where the services are to be provided. For any clarification (s) as to the tender/scope of work or inspection of the premises, the prospective bidders may contact with Indenter and Chairman(Works), at NRRI, Cuttack-753006 with prior appointment on any working day between 9.30 a.m to 5.00 p.m.
6. No interest on Security Deposit and earnest money deposit shall be paid by the NRRI to the tenderer.
7. Guarantee period: The guarantee period of the work should be minimum 03 years from the date of completion / handing over of the work.
8. Liquidated Damages: In case of delay in completion of the contract, liquidated damages will be levied 0.5% of the contract value, subject to a maximum of 10% of the contract value.
9. The security shall be valid till all contractual obligations are fulfilled by the firm. The same shall stand forfeited in case of cancellation of the contract for any breach of contract or for any deficiency in the performance noticed during the currency of the contract.
10. The tenderer are liable to be ignored if complete information as required is not given therein or if the particular asked for in the schedules to the tenders is not fully filled in.
11. Details of essential documents required for Technical evaluation of bids are provided in Annexure IV.
12. The Contract will be strictly monitored as per Scope of work given in Annexure II in respect of minimum standard defined in the said Annexure. In case any shortcomings or deficiencies are noticed during the currency of contract period or any other contractual dispute, the contract can be terminated giving by giving one month notice. The decision of Director, NRRI in this regard shall be final and binding.
13. After completion of work if within one year, any defect, or damage or poor workmanship is noticed, the same shall be rectified by the contractor within 10 days failing which the Security Deposit shall be forfeited.

14. Taxes viz Income Tax, Cess on I.T., 1% Labour Cess, GST (as per applicable), 2% TDS on GST, 5% DLP and such other taxes levied by Government from time to time will be deducted from the work bill. Labour cess **@ 1% of the gross value of work to be deducted from the contract's bill & to be remitted to the "Odisha Building & other Construction Workers' Welfare Fund"**
15. Payment will be made after 100% completion of the work on actual measured quantity basis and acceptance by NRRI through NEFT/RTGS/e-payment.
16. No part payment will be made for execution of the work.
17. Work order will be issued to the successful bidder after completion of all formalities of NRRI, Cuttack. The successful bidder has to enter an agreement after receipt of work order and before start of the work. If the tenderer does not start the work within 7 days of issue of work order or does not represent to the Director, NRRI, Cuttack stating a valid reason such as interference of natural phenomena or the circumstances beyond his control, the work order shall be deemed to be withdrawn without any notice and EMD will be forfeited. Decision of the Director, NRRI, Cuttack in this regard is final and binding on the tenderer.
18. Rates quoted by the bidder will be valid till completion of the work.
19. In case the work order is placed for execution, it will be incumbent on the tenderer to abide these terms and conditions and complete the work as per the schedule of works to the best satisfaction of the In charge, Engineering Section, NRRI, failing which the EMD will be forfeited and the tenderer is liable to pay the loss to be incurred by NRRI, to carry out the work/balance of work through any other agency.
20. If any damage occurs to NRRI property during execution of work including dismantling the same will be borne/repaired by the tenderer. For this reason, the tenderer is advised to inspect the work site before submitting the tender.
21. Director, NRRI is not bound to accept the lowest or any other tender and also reserves the right to reject any or all the quotations without assigning any reason thereof.
22. The tenderer will abide by the contract labour act, minimum wages act and other labour related acts, applicable during execution of the work.
23. The workers will be personnel of the tenderer and NRRI will have no responsibility whatsoever to them. Any liability that may arise due to death/injury to any of the workers while executing the work will be borne by the tenderer.
24. The foundation should be laid in such a manner that the new construction does not affect the old building.

The Contractor/Agency will perform the said works in the said orders and shall execute the same with great promptness, care and accuracy in a workman like manner to the best satisfaction of the Director, NRRI, Cuttack and will complete the same in accordance with the said specification and terms & conditions laid down in the above said work order. The NRRI will pay or cause to be paid to the contractor for the said works on final completion of the work(s) thereof and the amount due in respect thereof at the rate specified in the schedule here to refer. If during the performance of the work any theft, damage or losses to the property of NRRI is caused by contractor, but not occasioned by or arising out of Acts of God (Natural Calamity), or warlike operations the same will be made good by contractor at his own cost.

6. The firm shall provide a coordinator for immediate interaction with the NRRI.
