Terms and conditions:-

1. After completion of work if within one year, any defect, or damage or poor workmanship is noticed, the same shall be rectified by the contractor within 10 days failing which the Security Deposit shall be forfeited.
2. Taxes viz Income Tax, Cess on I.T., Labour Cess, GST (as per applicable), 2% TDS on GST, such other taxes levied by Government from time to time will be deducted from the work bill. **Labour cess @ 1% of the gross value of work to be deducted from the contract's bill & to be remitted to the "Odisha Building & other Construction Workers' Welfare Fund".**
3. **The successful bidder shall be required to deposit the 5% of the total contract value** through online payment gateway portal in our website (www.icar-nrri.in) or through bank to our **A/c No.- 10329386033** in favour of Director, NRRI, Cuttack-6 **in advance and the same may be returned after one year.**
4. Payment will be made after 100% completion of the work on actual measured quantity basis and acceptance by NRRI through NEFT/RTGS/e-payment.
5. **No part payment will be made for execution of the work.**
6. Work order will be issued to the successful bidder after completion of all formalities of NRRI, Cuttack. The successful bidder has to enter an agreement after receipt of work order and before start of the work. If the tenderer does not start the work within 7 days of issue of work order or does not represent to the Director, NRRI, Cuttack stating a valid reason such as interference of natural phenomena or the circumstances beyond his control, the work order shall be deemed to be withdrawn without any notice and EMD will be forfeited. Decision of the Director, NRRI, Cuttack in this regard is final and binding on the tenderer.
7. Rates quoted by the bidder will be valid till completion of the work.
8. In case the work order is placed for execution, it will be incumbent on the tenderer to abide these terms and conditions and complete the work as per the schedule of works to the best satisfaction of the In charge, Engineering Section, NRRI, failing which the EMD will be forfeited and the tenderer is liable to pay the loss to be incurred by NRRI, to carry out the work/balance of work through any other agency.
9. If any damage occurs to NRRI property during execution of work including dismantling the same will be borne/repaired by the tenderer. For this reason, the tenderer is advised to inspect the work site before submitting the tender.
10. Director, NRRI is not bound to accept the lowest or any other tender and also reserves the right to reject any or all the quotations without assigning any reason thereof.
11. The tenderer will abide by the contract labour act, minimum wages act and other labour related acts, applicable during execution of the work.
12. The workers will be personnel of the tenderer and NRRI will have no responsibility whatsoever to them. Any liability that may arise due to death/injury to any of the workers while executing the work will be borne by the tenderer.
13. **The successful bidder is required to dump all the estimated materials before starting the work and the same will be verify by the Chairman, works.**
14. In case of any dispute on execution or other issues related to this work, the decision of the Director, NRRI will be final and binding.
