- 1. Agreement for leasing will be for **three** years but every year the conduct and performance of the bidders will be reviewed for continuance based on our terms and conditions.
- 2. The bidder should quote their rate for the entire period of three years.
- 3. The lessee should follow the terms and conditions and other bindings related to security, law, and order of this Institute and maintain absolute discipline which should not hinder the day-to-day activity of the Institute.
- 4. The watch & ward of the pond will be done by the bidder or his representative but he should regularly take advice in this regard from the Security Officer of this Institute.
- 5. The lessee shall rear the fish in the pond and maintain the pond properly and keep the pond and its surroundings (10 feet of bank) weed-free. He has no right to the trees, plants and their produces or any structure coming within the periphery of the above ponds.
- 6. The lessee should not use any type of insecticide, pesticide, or chemical (which will contaminate the water and environment) to catch the fish or to clean the weeds in the pond.
- 7. The lessee should not sub-lease the same without prior permission of the ICAR-NRRI Authority.
- 8. The institute will use the water from this pond for irrigation as and when required. Only the required quantity of water will be left for sustaining the fishes.

- 9. On the expiry of the lease period, from the next day the lessee has no right on it. The above ponds will be under the control of ICAR-NRRI Authority in all respects. No correspondence will be entertained from the lessee by mortgaging the pond land/pond.
- 10. The lessee can not avail of any type of loan against this lease from any Govt./non-Govt. organization or private parties.
- 11. After termination of the lease, the lessee should hand over the demised pond in good condition and free from weed.
- 12. The harvesting and sale of fish should be done on holidays to avoid disturbance during office hours.
- 13. Cleaning of Pond: Cleaning of Pond and its surroundings is to be taken up by the Lessee immediately after the lease is awarded, at his own cost.
- 14. Any other point not covered in this agreement, will be intimated to the lessee beforehand and the same will form a part of the agreement and will be in force till the completion of the lease.

#### **Terms and conditions**
