Eligibility Criteria:

1. The bidder should deposit online an amount of **Rs. 5,000.00 (Rupees five thousand only) as EMD** in ICAR-NRRI Account (**Name of the A/c Holder: ICAR UNIT CRRI, Cuttack, A/c No.: 10329386033, Type of A/c : Current Account, Name of the Bank: State Bank of India, Name of the Branch: Nayabazar, Cuttack-4, IFSC Code: SBIN0002094**) before the last date of EMD submission through GeM. EMD of the unsuccessful bidder shall be returned without interest at the earliest on finalization of the Auction.
2. Copy of PAN No., GST No. & Aadhar/Address Proof, in the name of the proprietor/owner/firm/company is required to be uploaded on the GeM Portal. The document to be uploaded should be legible. In case the uploaded documents are not readable, the bid cannot be examined, and the bid can be rejected, thereby rejecting the bid of that firm.

Terms and conditions

1. The Unserviceable Material/items will be available on Auction "**As is where is basis**". The Unserviceable Material/items can be inspected by the interested parties on the date as mentioned above by contacting the Assistant Administrative Officer, Office of the Director, Store Section, ICAR-NRRI, Cuttack-753006 at telephone 0671-2367757 (Extension No. 2248). No request for inspection of items after submission of the bid will be accepted.
2. Bidder may note that the electronics waste material, if any, is required to be disposed in an eco-friendly manner by following the guidelines of Govt. of India in this regard. Therefore, for discarded electronic items only e-waste handling firms having a valid registration for this purpose with Ministry of Environment and Forests/ Central or State Pollution Control Board, shall be eligible to bid. Scanned copy of the valid certificate issued from Ministry of Environment and Forest/ Central or State Pollution Control Board for disposal / handling of e-waste (having validity at the time of filling of tender as well as at the time of actual lifting of the e-waste) should be uploaded on the portal otherwise bid will be liable for rejection.
3. The bid shall remain valid for 90 days after the date of bid opening. If any bidder withdraws his / her bid before the said period, this office shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
4. Conditional bid shall not be entertained.
5. **Evaluation criteria:** The successful bidder will be the one which offer the highest total rate for the entire lot of scrap as detailed above, no part lifting of the items shall be allowed. **The successful H1 bidder should deposit transaction charges in GeM Portal as applicable as per GeM provision before award of contract.**
6. All the bidders shall fill the details of EMD column on GeM Portal if the option is available before submission of bids.
7. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the Unserviceable Material/items.

8. The Unserviceable Material/ items is to be lifted up **within 10 days** on the issue of Release Order on making full payment in the form of online payment in **ICAR-NRRI Account (Name of the A/c Holder: ICAR UNIT CRRI, Cuttack, A/c No.: 10329386033, Type of A/c : Current Account, Name of the Bank: State Bank of India, Name of the Branch: Nayabazar, Cuttack-4, IFSC Code: SBIN0002094)**. Otherwise, the EMD money deposited will stand forfeited and the offer shall be awarded to the next eligible bidder.
9. The successful bidder must lift all the Unserviceable Material/items at his own cost.
10. The bid without EMD (online payment) will be liable for rejection. No offline EMD will be accepted.
11. The Institute does not guarantee to make any definite quantity and quality of articles available to the buyer.
12. The list of items shown is indicative, ICAR-NRRI reserves the right to add/delete/modify the quantity as found necessary.
13. The lifting of items must be done during working office house between 10am to 5pm only.
14. The lifting of the items shall be done without damaging the premises / roads / drains / etc. The buyer shall compensate the damages, loss, etc., in the event of any occurrence otherwise.
15. **No selection or sorting whatsoever of the goods will be allowed.** The entire lot should be cleared by getting proper Gate Pass from ICAR-NRRI, Cuttack-753006.
16. Any uncleared or un-noticed materials left over by the successful bidder within the premises cannot be claimed later.
17. No enquiry of bidder shall be entertained once the material is lifted by them.
18. The materials being disposed is to be treated in line with applicable rules/notifications/guidelines etc. as may be prescribed by the Government. The successful bidder shall be responsible to ensure this action.
