SCRAP ITEMS.**

Unserviceable scarp (electrical items, GI sheet, Iron materials, plastics and wooden materials) of ICAR-National Rice Research, Cuttack are to be sold / auctioned through public auction on **28.03.2024 at 11.00 am at ICAR-NRRI Cuttack** under "**as is where is basis**" condition with the following terms and conditions.

1. Interested bidders can inspect the scarp (electrical items, GI sheet, Iron materials, plastics and wooden materials) on **28.03.2024** between **10.00 am to 11.00 am**.
2. The bidders should Deposit an amount of **Rs. 20000/-** (Twenty Thousand) Only as Earnest Money Deposit (EMD) through Demand Draft only in favour of **Director, ICAR-NRRI, Cuttack** Payable at **SBI, Nayabazar Cuttack** before the spot auction is started.
3. The bids received without EMD will summarily be rejected.
4. The amount of EMD deposited shall be adjusted from the total amount of payment due from the successful bidder.
5. The EMD of remaining unsuccessful bidder will be returned to them, without interest after finalization of sale / auction to the successful bidder.
6. No items, once disposed of from the successful bidder shall be taken back by this office on any condition whatsoever. Any uncleaned or unnoticed materials left over by the purchases within the premises cannot be claimed later.
7. The bidder should conduct due diligence on all aspects related to the property to his satisfaction.
8. The bidder shall not be entitled to make any claim against the authorised officer in this regard at a later date.
9. The items shall be sold / auctioned to the highest bidders.
10. **The highest bidder should pay 1/3<sup>rd</sup> of the amount of the quoted price on the same day as security deposit and the balance amount within two days from the date of issue of bid acceptance letter.**
11. The material should be cleared away from this office premises within **three working days** from the date of issue of bid acceptance letter. There should not be any damage to the property of this institute / inconvenience in functioning.
12. On failure of the successful bidder in paying the balance amount, the entire deposited amount paid by the bidder shall be forfeited without any notice unless time is extended further in writing.
13. **The price bid document has to be submitted as per the Proforma (Annexure-I) along with the copy of PAN No., GST No. & Aadhaar / Address Proof, in the name of the proprietor / owner / firm / company on the auction day as specified above.**
14. The Unserviceable Material / items will be available on Auction "**As is where is basis**". 16. The successful bidder must lift all the Unserviceable Material / items at his own cost.
17. The Institute does not guarantee to make any definite quantity and quality of articles available to the buyer.
18. The list of items shown is indicative, ICAR-NRRI reserves the right to add / delete / modify the quantity as found necessary.
19. The lifting of items must be done during working office hours between 10 am to 5 pm only.
20. The lifting of the items shall be done without damaging the premises / roads / drains / etc. The buyer shall compensate the damages, loss, etc., in the event of any occurrence otherwise.
21. **No selection or sorting whatsoever of the goods will be allowed.** The entire lot should be cleared by getting proper Gate Pass from ICAR-NRRI, Cuttack-753006.
