EMD of the unsuccessful bidder shall be returned without interest at the earliest on finalization of the Auction.
- Copy of PAN No., GST No. & Aadhar/Address Proof, in the name of the proprietor/owner/firm/company is required to be uploaded on the GeM Portal. The document to be uploaded should be legible. In case the uploaded documents are not readable, the bid cannot be examined, and the bid can be rejected, thereby rejecting the bid of that firm.

Terms and conditions

- 1. The labour and transportation or any other incidental cost involved in plucking the fruits will be fully borne by the successful bidder.
- 2. The fruits will be available on Auction "As is where is basis". The fruit load on fruiting trees can be inspected by the interested parties on above mentioned date only by contacting the Assistant Administrative Officer, Office of the Director, Store Section, ICAR-NRRI, Cuttack-753006 at telephone 0671-2367757 (Extension No. 2248). No request for inspection of items will be accepted/considered outside the specified date and after submission of bid.
- 3. The bid shall remain valid for 45 days after the date of bid opening. If any bidder withdraws his / her bid before the said period, this office shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
- 4. Conditional bid shall not be entertained.
- 5. Evaluation criteria: Highest bid will be accepted subject to the approval of Competent Authority. The successful H1 bidder should deposit transaction charges in GeM Portal as applicable as per GeM provision before award of contract.
- 6. All the bidders shall fill the details of EMD column on GeM Portal if the option is available before submission of bids.
- 7. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the auctioned Material/items.
- 8. The auctioned material/ items is to be lifted up on issue of Office Order on making full payment in the form of online payment in ICAR-NRRI Account (Name of the A/c Holder: ICAR UNIT CRRI, Cuttack, A/c No.: 10329386033, Type of A/c: Current Account, Name of the Bank: State Bank of India, Name of the Branch: Nayabazar, Cuttack-4, IFSC Code: SBIN0002094). Otherwise, the EMD money deposited will stand forfeited and the offer shall be awarded to the next eligible bidder.

- 10. The applicable Transaction Charges shall be paid by the successful Bidder to GeM within 3 (three) working days of winning the auction lot. GeM at its sole discretion can extend the time for payment of the transaction charge.
- 11. The bid without EMD (online payment) will be liable for rejection. No offline EMD will be accepted.
- 12. The Institute does not guarantee to make any definite quantity and quality of articles available to the buyer.
- 13. The list of items shown is indicative, ICAR-NRRI reserves the right to add/delete/modify the quantity as found necessary.
- 14. The lifting/plucking of items/fruits must be done during working office hour between 9.00 am to 5.30 pm only.
- 15. The lifting of the items shall be done without damaging the premises / roads / drains / etc. The buyer shall compensate the damages, loss, etc., in the event of any occurrence otherwise.
- 16. The entire lot should be cleared by getting proper Gate Pass from ICAR-NRRI, Cuttack-753006.
- 17. Any uncleared or un-noticed materials left over by the successful bidder within the premises cannot be claimed later.
- 18. No enquiry of bidder shall be entertained once the material is lifted by them.
