**NOTICE INVITING EXPRESSION OF INTEREST (E.O.I)

BACKGROUND

ICAR-NRRI, Cuttack is working in the field of rice pest management since its inception and the institute has developed expertise in production & testing of Pheromone Traps for Stem borer, leaf folder, Helicoverpa, Spodoptera, etc. Recently, we have established pheromone production facilities with the support of RKVY, Government of Odisha. The said facility is primarily set up for meeting the small scale production requirement. The institute is also having robust testing and quality control facilities. However, the institute is having demand for in-house as well as external use for large quantity of the Pheromone Traps and Lures. In order to meet the full capacity production requirement in short period of time, the institute is looking to empanel reputed and experienced manufactures (on non-exclusive basis) those having high production capacity to produce and supply quality pheromone traps and lures, as per the demand from time to time. Presently on hand there is a requirement of around 10.00 lakhs Pheromone Traps with Lures.

SCOPE

STAGE-1:

The ICAR-NRRI, Cuttack will test the Traps & Lures of interested firms for the quality as per the prescribed standards, to check the suitability as indicated in the above background. The qualified manufacturers will be empanelled on non-exclusive basis and certified by the NRRI for recommending to various government and non-government agencies approaching the institute for supply of Pheromone Traps.

STAGE- 2:

The empanelled agencies will be recommended by NRRI to different agencies for placing orders as per their terms and requirement. Such requirement is to be subject to quality certification by NRRI, for which the sampling design and methods will be prescribed by NRRI and the samples will be collected by the institute at the source of supply, for quality certification and assurance for further acceptance of the product by the agencies, who placed the supply order. The final payment shall be paid by such agencies only after getting quality clearance certificate by NRRI.

ELIGIBILITY CRITERIA

The interested firms / manufacturers should possess the following minimum eligibility requirements:

- 1) Must have valid trade registration and licence to manufacture the Pheromone Trap and Lures and/or Insect Traps.
- 2) Minimum 05 years of experience in production and supply of Pheromone Traps & Lures and/or Insect Traps for agriculture use, {To be supported by producing copies of supply orders and respective Tax invoice, from government or/ and other agencies}
- 3) Minimum turnover of Rs. 15 crores per annum for a period of two financial years within span of 05 years {Supported by audited financial statements}.
- 4) Should have minimum production capacity of producing at least 50 lakhs pheromone traps and lures per annum {To be supported by production of list of equipment, facilities and manpower}.
- 5) The firm or its promoters/ owners / Director should not have been debarred or blacklisted from any of the government agencies {To submit an undertaking}
- 6) The applicant must have PAN in his/her name.
- 7) The firm should be registered with the Commercial Tax Department and posses GSTIN number.

CHARGES

There will be charges as per the following stages

- 1) EOI Processing Fee of Rs. 5000/- (Inclusive GST)
- 2) Testing and Empanelment Charges of Rs. 50,000/-. Site visit, extra as per actual (if applicable), which will be payable by the eligible manufactures after evaluation of EOI document
- 3) Quality testing and Quality Certification charges against the supply orders received under the MoU signed through EOI.
